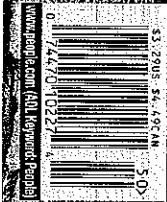

### Legal Notice

#### IF YOU PURCHASED ANY 1990 THROUGH 2001 MODELS OF THE AIDIAS "TOP," "PRO," "PRO DELUXE" OR "VENOM" SOCCER SHINGUARDS, THIS NOTICE OF SETTLEMENT MAY AFFECT YOUR RIGHTS. PLEASE READ IT CAREFULLY.

A proposed settlement of a nationwide class action lawsuit involving the purchase of certain Aidias soccer shinguards has been reached in *Shingard v. This proposed settlement applies to AWE if you are an individual who bought any of the following Aidias soccer shinguards prior to settlement date 09/30/02: 1) A 1990 through 2001 model of the Aidias "Top," "Pro," or "Pro Deluxe" shingard (this proposed settlement does not apply to the Aidias "Venom" shingard).

This class action is about whether Aidias made false representations concerning certain soccer shingards, and does not indicate a violation of any law. If this proposed settlement is approved by the court, you will receive a check for the amount of your purchase, or \$10 toward the purchase of at least \$15 worth of all the soccer shingards, or being on which the amount of your purchase. Courts will be determined through the Internet, at certain times. To obtain a copy of the settlement, you must submit a Claim Form together with Proof of Purchase or Declaration of Ownership to the court by April 3, 2003. IF YOU ARE A CLASS MEMBER AND DO NOT FILE A CLAIM FORM WITH PROOF OF PURCHASE OR DECLARATION OF OWNERSHIP BY THE FINAL DEADLINE, YOU WILL BE DEEMED TO HAVE RELEASED ALL CLAIMS RELATING TO YOUR PURCHASE OF ANY OF THE AIDIAS SOCCER SHINGARDS.

If you do not want to be a class member, you must exercise yourself as described in the detailed notice on later firm summary comment on the terms of the settlement. If you opt in the class, you may object to or comment on the terms of the settlement. The Court will hold a hearing on February 21, 2003 to consider whether to give final approval to the settlement.
